Good Neighbor Grant: For Environmental & Beautification Placemaking Initiatives

PURPOSE & GUIDELINES

As a Keep America Beautiful Affiliate, the Clean County Commission has been working with community volunteers to identify new strategies in the areas of sustainable waste management, [Placemaking](#), and beautification of our roadsides and common areas. Grant Awardees are required to conduct a litter cleanup in or near their respective neighborhoods during the project timeline to ensure that our neighborhoods are “LitterFree Sites”. The Application and Project Completion Report have new sections to describe the cleanup location and report on findings. The Clean County Commission thanks all participants for their continued support and dedication to Keep James City County Beautiful.

- 1) **Purpose:** The Clean County Commission is making ten \$500 **Good Neighbor Grants** available to neighborhood groups and homeowner associations available on a reimbursable basis (50% upfront and 50% upon project completion). The purpose of the grant is to enhance the sense of community and environmental wellness of our neighborhoods through the accomplishment of sustainable community planning.

- 2) **Project Description: Sustainable / Communal Landscaping:** Each community has unique individuals and needs. The purpose of this grant is to encourage community members to take pride in and responsibility for their communal space. Projects will focus on the physical aspects of common areas through the installation of native plants, erosion control methods, Placemaking for community members, and other methods to improve environmental quality and minimize negative impacts. Examples: community garden, entryway landscaping, trail improvements, communal compost, playground and pool area landscaping, energy saving techniques, and litter prevention measures. - 3) **Guidelines:** In order to compete for grant funds:
 - A. The applicant must complete a Good Neighbor Grant Packet (application, proposed project budget, before and after photos, relevant maps, letter of intent [when applicable], and checklist) and submit to the Environmental Sustainability Coordinator at 107 Tewning Rd. or email the application to cleancounty@jamescitycountyva.gov prior to **5:00 p.m. on September 15, 2020**.
 - B. The neighborhood association governing officials and/or committee members must sign this application in support of the project. Additionally, the neighborhood organization must maintain a record of volunteer & partner/sponsor support for said project for five (5) years. **By April 30, 2021, a Project Completion Report including after-action photos & receipts (reimbursement amounts) must be submitted to the James City County Environmental Sustainability Coordinator or the final payment will not be granted.**
 - C. The neighborhood association or committee must match dollar for dollar the grant amount. The match can be generated through: volunteer hours valued at \$26.09/hr. (virginiaservice.virginia.gov/resources/resources-data/volunteerism-statistics/) and/or in-kind goods and services and cash donations.
 - D. Upon request, a neighborhood representative can receive a preliminary review of their application prior to the submittal date by contacting the Environmental Sustainability Coordinator at 757-259-5375.
 - E. James City County/Williamsburg Master Gardeners will provide free assistance in plant selection and sustainable practices by contacting the Electronic Helpdesk at www.jccwmg.org. All flora to be planted must consist of native plants. - 4) **Special Instructions for Neighborhood Committees without Associations:** Applications from neighborhoods without an association must include signatures from at least two residents as well as three-fourths of the residents adjacent to the common area to be improved. All other requirements apply.

- 5) **Grant Application Review**
 - A. Clean County Commissioners will review applications and winners will be announced in September with 50% of the award presented upfront and 50% presented upon review of the Project Completion Report.
 - B. Applications will be evaluated based on the benefit to the community, community involvement, sustainability (supporting healthy habitats, native plants, water conservation), implementation of environmental measures, and those minimizing water runoff.
